- A. The successful recipient is not required to serve a bond with TMC.
- B. Applicants will be assessed according to their academic performance and working experience. Preference will be given to applicants who are actively involved in SAFRA events and/or activities.
- C. Previously sponsored candidates may apply again. However, priority would be given to first-time applicants.
- D. Short-listed candidates for Scholarship will be required to attend an interview session. TMC does not enter into correspondence with regard to the reasons for selection of application.
