RULES & REGULATIONS (R&R)

1. PERIOD AND VENUE OF TOURNAMENT

1.1. Date/Time

The SAFRA x STTA Championships 2022 (National Age Groups and Men's Open) will be held from 4 to 12 June 2022 from 8:30am to 10:30pm.

1.2. Venue

SAFRA Toa Payoh, 293 Lorong 6 Toa Payoh, Singapore 319387, Multi-Purpose Hall, Level 2

1.3. The Organising Committee, at its discretion, reserves the right to change the date, time and venue of the tournament, if such need arises.

2. ELIGIBILITY OF PARTICIPANTS

- 2.1. Only Singapore Citizens who are <u>fully vaccinated</u> are eligible to participate in this tournament, except for 9 & Under and 12 & Under categories where non-vaccinated are allowed. Participants with outstanding payments due to STTA must make full payment by 12pm on 11 May 2022 (Wednesday) otherwise he/she will not be included for the open draw. There will be no refund of registration fee, if paid.
- 2.2. Player(s) must produce their identification document during registration.
- 2.3. Age qualification shall be based on only birth year of participants as following:

| 9 & Under | Born in or after 2013 |
| 12 & Under | Born in or between 2010 and 2012 |
| 15 & Under | Born in or between 2007 and 2009 |
| 19 & Under | Born in or between 2003 and 2006 |
| Men's Singles | Born in or before 2002 |
| Men's Team Open | No Age Restriction |

- 2.4. Current full-time national players are not eligible to participate in any events, except Men's Team Open event as Graded Player.
- 2.5. Former full-time national players who have represented Singapore in SEA Games, Commonwealth Games, Asian Games, Olympic Games, SEA Championships, Asian Championships, Commonwealth Championships and World Championships from year 2017 2021 are not eligible to participate in Singles events.

3. **REGISTRATION OF ENTRIES**

- 3.1. A player is ONLY permitted to participate in a maximum of 1+1 events which includes one individual category that he/she is eligible for and one Men's Team Open event. For example, a 12 year old boy can only participate in "Boys' 12 and under" age group category and "Men's Team Open".
- 3.2. A Men's Open team shall consist of a minimum of three (3) players and a maximum of four (4) players. Each team can have a maximum of one Graded Player. Graded players are defined as
 - STTA National Team Players as of 31st December 2021
 - STTA Intermediate Squad Players as of 31st December 2021
- 3.3. Men's Singles category is open to all ages.











- 3.4. Men's team open category is open to all ages.
- 3.5. Amendments to Team Registration allowed before 2nd June 2022 (Thursday) at 12:00noon. The new player(s) must not have any records of registration in any teams registered for the competition.
- 3.6. Registration shall be done at SAFRA Customer Service Counters only. A receipt will be issued. The closing date for registration is Wednesday, 11 May 2022 at 12pm.

4. TOURNAMENT SYSTEM & RULES

- 4.1. Events may be played on a single knock-out system and/or group round robin system depending on the number of entries.
- 4.2. All matches for individual categories shall all be played to the best of 5 games of 11 points each.
- 4.3. All matches for the Men's Open will be single matches played to the best-of-5 games of 11 points each based on the following format:

- 4.4. This tournament shall be run in accordance with the latest rules and regulations of the International Table Tennis Federation (ITTF). Rules and regulations of the ITTF can be downloaded from <u>www.ittf.com</u>.
- 4.5. Only ITTF approved racket coverings are allowed to be used throughout the tournament.
- 4.6. The ITTF approved 3-star <u>white</u> balls shall be used during this tournament.
- 4.7. No white apparels (shirt and shorts) are allowed. All players of a team taking part in the team event shall be dressed uniformly, with the possible exception of socks, shoes and number, size, colour and design of advertisements on clothing. Players who fail to conform shall be disqualified.
- 4.8. All players are only allowed entry into the competition hall:
 - Individual events: 10 minutes before match.
 - Team events: 10 minutes before match.
- 4.9. Teams shall submit the line-up form 25 minutes before the scheduled time. If the line-up form is not submitted on time, the Referee team shall fill in the line-up according to the order in the Team Registration Form.
- 4.10. Player shall concede a walkover, if the player is not on court at the scheduled time after the match has been announced on court. There shall not be any grace period.
- 4.11. Umpires will be provided for matches from Quarter-Finals onwards except for 9 & Under categories.
- 4.12. This tournament is part of the National Ranking Policy. Seeding for the next tournament will be in accordance with the National Ranking Policy.
- 4.13. If a player does not show up for all his/her matches for a registered event, no penalty points will be imposed.











- 4.14. In the event a walkover is conceded in a group stage match, a player can still play in the remaining match(es) in his/her group stage with no penalization or deduction of national ranking points.
- 4.15. However, if the player <u>conceded walkover in the knock-out stage</u>, he/she will be imposed with penalty points per match which he fails to show up for that registered event if he is unable to produce a valid written explanation within 7 days from the last day of the tournament. The number of penalty points will be calculated as two times (2x) the rating points the player is supposed to get for the stage of the event he reached. For players being awarded penalty points, rating points shall still be awarded based on the stage of the event he reached. In addition, disciplinary action will also be taken by STTA.
- 4.16. All players are requested to bring their identification documents for verification on the days of their matches, failing which they will <u>not</u> be allowed to play.
- 4.17. Each player in the individual category is allowed to have an accompanying coach (who must have a valid NROC membership) to provide side coaching for his/her match(es). Proof of valid NROC membership must be shown at the venue entrance. Coaches who failed to provide proof shall be denied entry. No coaches are allowed for Team competitions unless they are playing for the team (i.e. Player-Coach).
- 4.18. Spectators are **not allowed** inside the competition hall due to venue restictions. Matches from the Semi-Finals onwards will be streamed live on SAFRA Toa Payoh Facebook page.
- 4.19. The complete entry list shall be published at the following websites: www.safra.sg or www.stta.org.sg from Wednesday, 18 May 2022 onwards. Any discrepancy or omission of entries must be brought to the attention of SAFRA Toa Payoh or STTA by 22 May 2022 (Sunday), 12pm. Strictly <u>no changes</u> shall be made after the omission check.
- 4.20. An open draw for all categories will be conducted on <u>Wednesday, 25 May 2022</u> via Zoom (details shall be email to all participants) at 7.00pm. All are welcome to witness the draw.
- 4.21. Participants are to check their fixtures on <u>Friday, 27 May 2022</u> at the following websites: <u>www.safra.sg</u> or <u>www.stta.org.sg</u>

5. PRIZES & INCENTIVES

5.1. Prizes breakdown shall be as follows:

- 5.2. The Prize Presentation Ceremony shall be held at SAFRA Toa Payoh, Multi-purpose Hall Level 2 on 12 June 2022 (Sunday) immediately after the finals of the last event. Trophies/medals will be awarded to top 8 winners of each age group categies. Also, trophies/medals will be awarded to top 4 winners of the 'Men's Singles' and 'Men's Team Open' categories.
- 5.3. All prize winners MUST be present personally at the ceremony in neat attire (no singlet, slippers and sandals) in order to receive their prize/s. Player who concedes walkover from quarter-finals onwards will not be entitled to receive any prizes.











5.4. The Organizing Committee reserves the right not to award the prize money and trophy if Regulation 5.3 is breached. In addition, if a player who must attend the prize presentation failed to show up, the rating points that he should have obtained from the event would be forfeited.

6. SUPPLEMENTARY RULES

- 6.1. The Organising Committee has the absolute rights to interpret or amend the rules and regulations of the tournament at any time. Notifications of such changes will be posted on relevant website. It is the sole responsibility of the participant to visit the SAFRA or STTA website for any notices or changes to the draw or schedules. Any changes will be posted at least 24 hours before the re-scheduled match. Any other rules and regulations that are not covered by the Rules and Regulations will be decided by the Organising Committee, whose decision shall be <u>FINAL</u>.
- 6.2. In any event of a dispute or seeking redress, please lodge your appeal in writing together with the <u>protest fee</u> <u>of \$50.00</u> with the presiding official <u>on the spot</u> during the match. In the event of the protest being dismissed, the fee will be forfeited.
- 6.3. In the event of any dispute arising over any player, the match shall be played under the protest and the Organising Committee shall determine the matter on receipt of the protest.
- 6.4. While reasonable precautions are taken, SAFRA, and its agents will not be responsible or in any way liable for any death, disability, personal injury, loss of property or any loss howsoever arising from any cause whatsoever at any time during the course of this event.
