## TERMS & CONDITIONS

### 1. **Organiser:**

'SAFRA BUDDIES DAY OUT' by SAFRA Youth Network (the Event) is organised by SAFRA National Service Association (SAFRA).

### 2. **Agreement to Terms:**

By registering to the Event, each participant agrees to be bounded by these Terms and Conditions, including consent to SAFRA's collection of your personal data in order to conduct the Event and agree that SAFRA may, for this purpose, collect, use and/or disclose your personal data in accordance with these Terms and Conditions and SAFRA's Privacy Policy at, <https://www.safra.sg/privacy-policy>. All rules and regulations and instructions issued by SAFRA from time to time will be deemed incorporated in these Terms and Conditions. SAFRA reserves the right to amend the Terms and Conditions of the Event, at any time, without prior notice.

### 3. **Eligibility:**

- a) The Event is open to all SAFRA members and members of the public (the Participant) located in Singapore.
- b) Registration fee is applicable as stated in the registration website
- c) SAFRA staffs, permanent or temporary, are not qualified to participate in the Event.

### 4. **How to Join:**

- a) Participants will have to register via mySAFRA to receive goodie bag during the event. Successfully registered participants will receive an automated confirmation email.
- b) Participants will have to present your Email Receipt / SAFRA E Card (Main registrant) on the event day to receive a goodie bag.

### 5. **Event Information:**

#### General Information

- a) The Event will run on Saturday, 5 August at Gardens by the Bay, SG50 Lattice, from 4pm to 6pm. Registration will start from 3pm onwards.
- b) The event welcomes participation from a wide range of pets as long as their ownership and presence comply with the laws and regulations of Singapore.

- c) Participants must ensure that their pets are legally allowed to be kept and brought to public events in Singapore. This includes adhering to licensing, vaccination, and any other relevant requirements set by local authorities.
- d) Pet owners are responsible for the safety, behaviour, and well-being of their pets throughout the event. Aggressive or disruptive pets may be asked to leave the premises for the safety of other participants and attendees.
- e) All pets must be properly leashed, harnessed, or contained within appropriate enclosures to prevent any incidents or potential harm to other participants, pets, or property.
- f) Pet owners are required to promptly clean up after their pets and dispose of waste in designated bins. Failure to comply may result in removal from the event area.
- g) How to get there:

### By Car

- I. Parking will be available at Bayfront Plaza Carpark and The Meadow Carpark.
- II. Please be aware that the carpark at **Bayfront Plaza** will be temporarily closed from 6pm to 9pm.
- III. Kindly ensure that you remove your car from the Bayfront Plaza Carpark before 6pm.
- IV. If your vehicle remains in the carpark during the closure period, you will only be able to retrieve it after 9pm.
- V. The information is subjected to change by Gardens by the Bay management

Parking at The Meadows carpark is encouraged to avoid the closure. Please take note of these parking arrangements and plan accordingly to avoid any inconvenience.

#### **Via The Circle Line Or Downtown Line**

Alight at Bayfront MRT Station (CE1/DT16)

Take Exit B and follow the underground linkway

Exit and cross the Dragonfly Bridge or Meadow Bridge into Gardens by the Bay

### **Via The East-West Line**

Alight at Tanjong Pagar MRT Station (EW15)  
Take Exit C and head towards bus stop no. 03223 located at International Plaza, Anson Road  
Hop onto bus 400 and alight at bus stop no. 03371 along Marina Gardens Drive

### **Via Thomson East-Coast Line**

Alight at Gardens by the Bay MRT Station (TE22)  
Take Exit 1 into Gardens by the Bay (beside Satay by the Bay)

### Weather Condition

- a) The programme and activities are subject to change based on prevailing weather conditions.
- b) In the event of a Category 1 rain condition, the event will be cancelled for the safety of all participants and attendees.
- c) Please note that weather conditions can be unpredictable, and the organizers prioritize the safety and well-being of everyone involved. Any changes or cancellations will be communicated through appropriate channels.
- d) Please note that no refund will be provided for event registrations in case of cancellation due to weather conditions.
- e) Participants, however, will still be eligible to redeem a goodie bag on alternative dates or at specified redemption points.

### Pet's Walk

- a) **Pet Requirements:** All participating pets must be adequately vaccinated, healthy, and well-behaved. Participants are responsible for their pets' behaviour and must ensure they are on a leash or contained within a suitable carrier throughout the event. All pets must always follow the guidelines pertaining to safe dog handling and guidelines provided on the following websites regarding muzzling of some dogs:

- e) **Event Changes:** The event organizers reserve the right to modify, postpone, or cancel the 1km Pet's Walk due to unforeseen circumstances or safety concerns. Any changes will be communicated through official channels, and alternative arrangements may be offered.

### **10. Notice:**

- a) The decision of SAFRA on all matters pertaining to the Event (including any dispute arising from the Email or interpretation of these Terms and Conditions) shall be final and binding on all parties. No correspondence or further claims shall be entertained.
- b) You hereby agree and acknowledge: (i) that all electronic communications made pursuant to the use of the Email and/or participation in the Event shall be given legal effect, validity, and enforceability and shall have, between the parties thereto, comparable evidential value to that accorded to a signed written document; (ii) not to Event, the legally binding nature, validity, or enforceability of any transaction on the Email on the ground that it was entered into electronically.

### **11. Governing Laws.**
